## Reminders for all shipments

Country of origin markings of the contents are required on all packages and preferably also shown on the shipment's packing list.

Packing lists must reference the foreign buyer's purchase order # even if an interim PO # is assigned by a middleman sales office. FPA can only receive against the principal's PO number.

A hard copy of the 7525 V (export declaration) is available from FPA upon request from the USPPI. This includes the ITN issued by Census. If not requested, this format will not be provided.

FPA's "default" consolidation warehouse is Maple Logistics, York, PA. Break Bulk cargo (too large to fit in a container) and certain containerized project cargo is routed to DSV in Baltimore, MD. Other US consolidation points may be used, such as Houston. When the US supplier controls the cargo inland routing (usually FCA terms), clarification of which US receiving warehouse the cargo should be consigned to MUST be made with FPA prior to shipping. Clarification is required regardless what "ship to" instructions are shown on the principal's purchase order. Shipping to the incorrect consolidation warehouse could result in the assessment of diversion charges.

An MSDS is required to be provided to FPA for restricted Articles (HAZMAT) BEFORE the cargo is shipped to the FPA consolidation warehouse.
